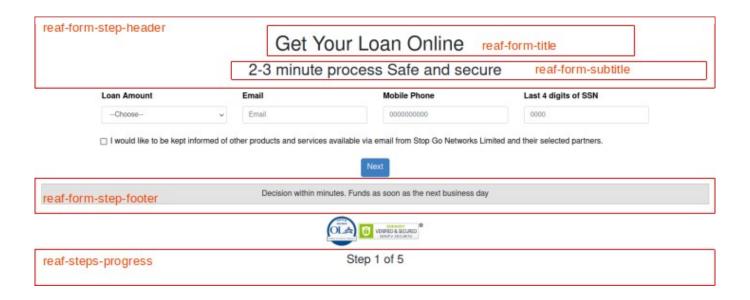
Introduction

This document describes how to render a Stop Go Networks REAF application form inside an affiliate website. By using REAF affiliates can render a vertical based application form on their website.

The system supports form pre-population by defining field values in the javascript. Once the applicant has rendered the form, the pre-populated values will be retained until the application is submitted.

CSS styling

Affiliates have a degree of freedom for styling REAF. All the HTML elements have CSS ids and classes prefixed with 'reaf-'. See the example below. Affiliates' developers must inspect the REAF generated HTML for a full breakdown of the REAF CSS elements.



Javascript code

The example below shows the minimal part required to start REAF. Note that your account manager will provide the following parameter values:

- account
- service
